Fostering Rural and Indigenous Community Well-Being with Asset-Based Development

Why You Matter

Federal and state agencies have the opportunity to address systemic disparities and build resilience in rural and Indigenous communities. To be effective, solutions must **center local leadership, invest in capacity**, and **measure success by community well-being**, not just dollars spent or jobs created.

Community

Core Insight

Health, economic development, and community well-being are inseparable. Sustainable outcomes require **trusted** intermediaries, flexible funding mechanisms, and inclusive engagement strategies.

Key Government Recommendations

Fund and Scale Rural Development Hubs

- Provide **flexible**, **operational funding** to Rural Development Hubs to coordinate local, regional, and cross-sector efforts.
- Support the position of Hubs as key equity, health, and resilience infrastructure within governmental networks.

Build Leadership and Organizational Capacity

- Invest in **staffing, training,** and **coalition building** across rural and Indigenous communities.
- Support technical assistance to help communities access, manage, and maximize federal funds.

Incentivize Regional, Cross-Sector Collaboration

- Encourage a culture of collaboration among State and Federal Agencies that allows regional design and implementation.
- Design funding programs that **reward collaboration** between counties, State Agencies, Federal Agencies, Tribes (where applicable), nonprofits, and economic development actors.
- Promote shared metrics of well-being, beyond transactional outputs.

Support Local Wealth Building

- Invest in systems for small business development, shared ownership, and asset acquisition.
- Enable tools like matched savings programs or community land trusts.

Elevate Community-Defined Metrics and Impact

- Co-develop performance measures with communities at the outset.
- Accept **qualitative metrics** and storytelling as valid indicators of success.
- Remove reporting burdens that do not serve program learning or outcomes.

Key Takeaway

Government programs can be more effective when they support trusted, local infrastructure, fund leadership and capacity, and evaluate success through community-defined well-being.

Community Change Grants

The EPA Environmental and Climate Justice Program's Community Change Grants are designed to support disadvantaged communities in addressing environmental and climate justice challenges, including building community capacity for sustained engagement with environmental and climate justice issues.

In a notable shift, the EPA has prioritized funding community-based organizations (CBOs) over traditional recipients like government agencies or large nonprofits. Recognizing that many CBOs lack the resources or expertise to navigate complex federal grant processes, the EPA is investing heavily in technical assistance (TA) to ensure more equitable access to funding opportunities.

Through the Inflation Reduction Act, the EPA received \$200 million specifically for TA initiatives. A portion of this funding was allocated to EnDyna, a firm contracted to provide comprehensive support for potential grantees. The goal is to empower community organizations by equipping them with the skills and tools needed to apply for and manage federal funding.

By embedding TA into the grantmaking process, the EPA is addressing systemic inequities in access to federal funding. This model facilitates broader participation from underrepresented communities and builds long-term capacity for local leadership and resilience.

This initiative exemplifies how government agencies can reimagine traditional funding processes to align more closely with the needs of historically marginalized communities.
